

WE ICE DETAINEES have suffered far too long, All the while ICE has remained silent and McHenry County Jail has continuously violated our every rights, civil and constitutional rights are just a few. WE have spoken out about these violations for far too long and have been ignored and disregarded like we are non-existent and ~~is~~ treated as the "Aliens" they like to call us or refer to us by. From the unconstitutional measures and detainment procedures being forced upon us, such as prolonged detention, cancellations of our court dates by the jail, refusal to take us to court by McHenry County Jail Staff and administration. Those are just a few. We have also been forced to quarantine, by the jail even though we are not sick, being made to spend 2 days in your ~~own~~ cell to receive 1 hour up every 2 days for periods of 14 days total quarantine and being given no other alternative to comply or face the consequences. Some of us have suffered in silent because we have not spoken out, there are those who have spent half their time here or about 75% of time they've been here under forced quarantine at McHenry County Jail. One can't quarantine the healthy and sick, I am not <sup>sure</sup> if this jail has an idea of what that does to one's mental, physical and psychological health, but I'm sure they are well aware and have heard every single one of ICE detainees cry for help and petition for these unlawful measures to be put to an end. WE have all been detained for far too long without being allowed to see a judge, due process and have received, one could say the same treatment as if we were federal terrorist prisoners at Guantanamo Bay, with no clear release date, no bond just for being ~~being~~ "undocumented Aliens" and our cases have all been put on hold while detained here at McHenry County Jail. Those are the procedures and practices they follow here. It is utterly ridiculous and unbelievable that murderers, car jackers and kidnapers in other words real criminals are eligible for a bond in the state of Illinois and in the US and one who ~~is~~ just because they are not documented, don't have a bond or aren't eligible for one. ~~in jeopardy~~ ~~by the jail~~ ~~and their staff~~ ~~they brought covid in the jail~~ ~~and we have been made to pay the consequences for their incompetence, they have played Russian Roulette with the lives of ICE detainees out will for far too long under the nose of the US government. The poor medical care, to non-existent <sup>care</sup> that we receive here is another issue, if they aren't ignoring our request, they are jokingly taking our health for granted by ~~saying~~ telling us "to drink some water, well be fine" and the malnourished meals that we receive are just enough to get us by and keep us breathing. How long can we be ignored, ~~while~~ while our civil and constitutional rights continue to be violated. We demand our release under these violations, unlawful detainment practices and procedures.
